Quick Start Guide

**TERMS OF USE:** Ubiquiti radio devices must be professionally installed. Shielded Ethernet cable and earth grounding must be used as conditions of product warranty. TOUGHCable™ is designed for outdoor installations. It is the customer's responsibility to follow local country regulations, including operation within legal frequency channels, output power, and Dynamic Frequency Selection (DFS) requirements.

## Hardware Installation

These instructions show the IsoStation; however, they also apply to the PrismStation.

1. If removing the horn to change it out for a different model, first rotate the horn counterclockwise while depressing the *Release Button*.



2. To insert the PrismAP, align the arrow on the PrismAP with the *Release Button*.



3. Press down on the PrismAP and rotate it clockwise until you hear a click.



4. Follow the installation instructions in the Quick Start Guide of your IsoStation or PrismStation.
